- Cllr Wilkinson attended the Norwich Airport Consultative Committee on 10
 October 2018. The minutes of the previous meeting stated that BDC had
 agreed to the masterplan, although it has been confirmed that this is not the
 case.
- The Post Office within Tesco at Acres Way will be closed from 1st to 24th November for a refit.
- The Remembrance Day Service will be on 11 November 2018 at St Margaret's Church, starting at 10.30am with a wreath laying ceremony. Refreshments will be served in the village hall after the service. On the previous day, 10th November, there will be an afternoon of tea and music to commemorate the ending of World War One at the village hall. The event starts at 2.15pm.

Response to Broadland District Council

Planning Application

20181623 Hill House, Hall Lane. Demolition of Dwelling and Erection of 56 Bed Nursing Care Home Comprising Two Separate Blocks of Accommodation, New Vehicular Access and Associated Landscaping

The Parish Council discussed the above application on 1st November 2018. The Parish Council fully supports the concept of the project and acknowledges there is demand for this type of facility.

The Parish Council does not support the application as currently proposed because of a number of concerns and fully endorses the objections raised by Highways:-

- SHCR 02 The proposed development does not adequately provide for pedestrians/ people with
 disabilities (those confined to a wheelchair or others with mobility difficulties) to link with existing
 provision and /or local services. Contrary to Development Plan Policies.
- SHCR 33The proposal is remote from local service centre provision conflicting with the aims of
 sustainable development, the need to minimise travel, and the ability to encourage walking, cycling,
 use of public transport and reduce the reliance on the private car as represented in national and local
 policy. Contrary to the National Planning Policy Framework and Policy 5 of Norfolk's 3rd Local
 Transport Plan, entitled Connecting Norfolk.
- 3. SHCR 17 The proposal does not incorporate adequate on-site vehicular parking and manoeuvring facilities to the standard required by the Local Planning Authority. The proposal, if permitted, would therefore be likely to lead to an undesirable increase in on-street parking to the detriment to highway safety. Contrary to Development Plan Policies.



In addition, the Parish Council has concerns in respect of sewage from the site and feels that the system proposed needs addressing. Connection to the mains sewers would be preferable to reduce any potential additional risk of surface flooding to the village and to eliminate any potential unpleasant smells.
