Planning Permission had been granted for Manor Park Development again. The

decision notice had not been issued for this permission as the S106 agreement
had yet to be agreed and signed.

In response the Chairman of the Parish Council expressed disappointment that an opportunity to address some of the issues raised at the original application point

had not been fully considered and that major concerns over flooding, the time line of the development and the increase of housing numbers on the site meant that the application could have been rejected.
