The Chairman opened the meeting, welcomed those present and advised that a late planning application had been received and the planning authority would not grant an extension for comment to the Parish Council. The deadline date was 19th September 2018. Therefore this application would be considered tonight under agenda item 7. Agreed.

1. Cllrs Blaxter, Brown Smith & Wilson – apologies received and accepted.

92. <u>Declarations of Interest</u>

2. Nothing further was declared beyond those interests already included on the register of member's interests.

93. Minutes of Meetings held 2nd August 2018

3. The minutes having been previously circulated were signed as a true and accurate record by the Chairman.

94. Public Participation

4. Representations were received in respect of the planning application for Drayton Old Lodge. There were considerable concerns over highway safety & environmental damage due to the number of trees to be felled. It was also felt the affordable housing quota had been squeezed on the site and as a result had increased overall dwelling numbers.

Annie Sommazzi gave a presentation about planning application 20181358. Concerns were expressed about security although a number of these issues were being addressed. It was also felt that good use of the footpath would also help reduce any anti social behaviour that might arise. The footpath did support Drayton's Neighbourhood Policies concerning Green Infrastructure (GI).

20181311 – 1a Magnay Road. Single Storey Side Extension to Form Annexe. **RESOLVED**: No objections to the above application, however concerns to be raised with the planning authority that this type of scheme means that parking spaces are being lost.

20181358 - Reepham Road Treebelt Thorpe Marriott. Creation of Footpath to Link Thorpe Marriott Estate, Marriott's Way, Nabour Furlong, Pendlesham Rise, Littlewood and the Broadland Northway Green Bridge.

RESOLVED to support the application.

99. General Matters

9.1 Uncirculated Correspondence. The list was noted.

9.2 NDR Western Link meeting held 9th August 2018. Over 1000 people had attended roadshows held over 11 consultations. The vast majority of consultees were in favour of completing the missing link of the NDR to the A47. Highways England confirm three other major projects would be undertaken to underpin the western link. These are Thickthorn junction improvements due in Spring 2020, dualling of west and east side of A47 due in 2020/21. The western link road would be a single road to link up the NDR and A47 and protecting the River Wensum site is of paramount importance.
9.3 Remembrance Sunday 11 November 2018 events. A meeting had been held with the new Vicar of St Margaret's to discuss. The Church wish to get involved in the *here but not here* campaign and also have refreshments after the service in the Bob Carter Centre or Village Hall. It was noted that Paul Miles, a local stone mason, has agreed to clean the war memorial for free. Permission has been obtained from Broadland District Council as the memorial is listed. **RESOLVED** that the Clerk and the Chairman work with those groups and individuals responsible for the events within the Parish. Grants monies may also be available to add to the budget of £2500 for the event.
