1. Cllrs Binns, Brown and Wilson – apologies received and accepted.

- Concerns were raised regarding the Manor Park development. The details of the section 106 funding to relieve traffic speeding and illegal rat running along Carter Road was not known. A full planning application is expected early in 2020.

Cllr Adams advised that the wall adjacent to School Road opposite the Lloyds Pharmacy is encroaching on to the Highway and requires a permit to be issued.

District Councillor (Drayton North)

Cllr Crotch advised that he had spoken to planning officers ahead of the proposed full application for Manor Park Development from Hopkins Homes expected in early 2020. At the recent Broadland Community at Heart awards Stacy Bradley of the Taverham and Drayton Litter Pickers won the award for Environmental Champion of the Year. Stacy has been instrumental in the group's success, securing sponsorship from local businesses and encouraging local residents to take part in litter picks. In August residents collected 33 bin bags weighing a total of 135.8kg.

Planning application 20191751 Brooklands Nursing Home. This application concerns improvements to facilities for both residents and visitors. There is a proposal for a limited increase in the number of parking spaces which is certainly needed. Other proposals include improvements to dining facilities, lounges and general updating for residents. There is no proposal to increase the number of residents at the care home. Most of the proposed changes affect the internal layout making better use of existing space. The case officer is content with the application.

Planning application 20191772 3 Drayton Lodge Park consists of a Single Storey front extension and new side entrance. Front extensions are rather unusual although in this case it is considered that there is adequate screening. The case officer does not envisage any problem.
