- 49. Apologies were **RECEIVED** and **ACCEPTED** from Cllr C Binns alternative engagement.
- 50. Members' declarations of interest and requests for dispensations. None.
- 51. The minutes of the Full Council Meeting held on 2nd July 2020 were **AGREED** as a true and correct record and will be signed by the chair in due course.
- 52. Public Speaking.

Speeding at Longdale was brought up along with illegal moped riding, the police have been in attendance.

- 53. To receive any reports:
 - 53.1 County Councillor Anthony Adams reported that the white lining between the Hall Lane mini roundabout and Drayton Lane will be addressed shortly. The junction with Costessey Lane and the A1607 is programmed for resurfacing.
 - 53.2 District Councillor A Crotch, Drayton North will be continuing to address concerns over police presence in Drayton. Broadland District Council is putting a paper to cabinet regarding homelessness. The HelpHub is undergoing some changes but is continuing.
 - 53.3 District Councillor R Foulger, Drayton South sent apologies.

Bird strikes are surprisingly high at the Airport given the lock down reduction in flights. This is being investigated.

The drone being flown at Longdale in January 2020 has been reported to the CAA as it is within 5 miles of an airport.

The fair has requested a visit in September. Under delegated powers the Clerk will be advising that the football has commenced at this time and therefore the field is unavailable.

The quality of the playground signage allowing the play areas to re-open at Hellesdon and Drayton has been positively commented on by the Broadland District Council chairman.
