5. Co-option to the Parish Council

No applications received.

6. To receive any questions or comments from members of the Public on matters on the agenda

The Tesco Community Champion handed around some leaflets. A bucket collection for Blood Bikes had raised over £700. The Carnival Co-ordinator was introduced and it was suggested that an email could be sent to digest the proposals.

### 7. To receive any reports:

- county Councillor Tony Adams reported that a meeting had taken place regarding the Taverham Road shops with PC Wright and the Highways Engineer. Zigzag lines with gaps would be put onto the road. The shop owners were prepared to contribute towards the car park repairs but this was not progressed as the landowner would not give permission. It was noted that the highways engineer was leaving his role shortly and a replacement had not yet been appointed. It was noted that planning issues in Taverham would affect Drayton, and therefore Drayton should be consulted on some matters such as access. Tony Adams would ask whether Taverham Parish Council had been consulted on any planning matters near Felsham Way (1,477 houses off Fir Covert Road) and would drop the information to the Chairman or the Clerk. It was noted that the Highways Drayton sign had not yet been reinstated.
- b) Drayton North District Councillor Adrian Crotch reported that there were no planning applications in Drayton North. The Streetlighting matter was passing through the Committee system and it was hoped that this would be finalised by the end of December so that it could be built into the budget. It was confirmed that Cabinet was scheduled to make a decision on 21st December 2021.
  - Drayton South District Councillor Roger Foulger was not present.
- c) PC Alex Wright reported that Online Priority meetings were replacing SNAP meetings, which would not be held face to face for a while. There had been two thefts from motor vehicles recently so residents needed to be vigilant. Crime prevention advice was available from the Police. There had been some antisocial behaviour at Longdale but the pictures had not been clear enough to identify the culprit, it was noted that the cameras may need cleaning or adjusting.

  ACTION: Clerk The Council was asked whether Longdale Pavilion could be used for engagement surgeries, it was agreed that this was acceptable.
